

3. The appointment will be made on deputation on foreign service terms initially for a period of two years and will be governed by the instructions issued by the DoP&Trg. OM No. 6/8/2009-Estt. (Pay II) dated 17th June, 2010, as amended from time to time. **The maximum age limit for appointment on deputation basis shall be not exceeding 56 years as on the closing date of receipt of application by TRAI.**

All the Ministries/Departments including officers from the Armed Forces, Central Public Sector Undertakings and Statutory and Autonomous Bodies are requested to forward applications in the prescribed proforma (*can be downloaded from TRAI's website www.trai.gov.in*) along with attested copies of ACRs/APARs for the last five years and vigilance/disciplinary clearance of eligible candidates whose services could be placed at the disposal of the Authority immediately in the event of their selection. The application should be sent in an envelope superscribing the post applied for to the **Senior Research Officer (A&P), Telecom Regulatory Authority of India, Mahanagar Door Sanchar Bhawan, J.L. Nehru Marg (Old Minto Road), Next to Zakir Hussain College, New Delhi-110002. The last date for receipt of applications is now extended up to 30th September, 2016.**

5. The candidates, who have submitted their applications for the above mentioned post in response to vacancy circular of even No. dated 6th July, 2016 need not apply again.
