Sub: Calling applications for filling up the post of Advisor

Sir,

The Telecom Regulatory Authority of India (TRAI), New Delhi is a statutory body set up under an Act of Parliament viz. the TRAI Act, 1997. The organization proposes to prepare a panel of officers having the required experience for appointment as Advisor in Broadcasting & Cable Services Division on deputation on foreign service terms initially for a period of two years. The details of qualification and experience etc, are as under:-

Name of the post	Scale of Pay	Qualification/Experience
Advisor (Broadcasting & Cable Service)	Rs.37400-67000 + grade pay Rs.10,000/- plus allowances such as DA, HRA, CCA etc as per Govt. Rules	Officers of the Central Govt., Public Sector Undertakings and Statutory and Autonomous Bodies (i) holding equivalent post on regular basis or (ii) Officers in Selection Grade with six years of regular service in that grade or (iii) Group A officers having twenty years of regular service in Group 'A' of which at least six years continuous service shall be in the Selection Grade. <u>Essential</u> : A Master/Bachelor's Degree in Business Administration/Economics/Commerce/Engineering/Law/Science/Humanities from a recognized University/Institution and possessing requisite experience in the Broadcasting related field. <u>Age</u> : Not exceeding 56 years on the date of closing of applications

2. The Appointing Authority may, from time to time, by appropriate order, appoint on permanent absorption basis any person already appointed on deputation in the Authority in accordance with provisions contained in TRAI Appointment Regulations.

3. TRAI has been exempted from the rule of immediate absorption upto 23.01.2011 by Department of Pension and Pensioner's Welfare for appointment on deputation.

However, TRAI has taken up the matter with the Government for exemption from the applicability of the rule of immediate absorption for all posts in TRAI.

4. All the Ministries/Departments, Public Sector Undertakings and Statutory and Autonomous Bodies are requested to forward applications in the enclosed proforma (can also be downloaded from TRAI website www.trai.gov.in alongwith attested copies of ACRs for the last five years and vigilance/disciplinary clearance of eligible candidates whose services could be placed at the disposal of the Authority immediately in an envelope superscribing the post applied for so as to reach the Senior Research Officer (A&P), Telecom Regulatory Authority of India, Mahanagar Doorsanchar Bhawan, J.L. Nehru Marg, (Old Minto Road), next to Zakir Husain College, New Delhi-110 002 on or before **8th May 2009**.
