Sub: Calling applications for filling up the post of Advisor (Financial Analysis) on deputation basis

Sir,

The Telecom Regulatory Authority of India (TRAI), New Delhi is a statutory body set up under an Act of Parliament viz. the TRAI Act, 1997. The organization proposes to prepare a panel of officers having the required experience for appointment as Advisor (Financial Analysis) on deputation on Foreign Service terms initially for a period of two years. The details of qualification and experience etc. are as under:-

Officers of the Central Govt., Public Sector Undertakings and Statutory and Autonomous Bodies (i) holding equivalent post on regular basis or (ii) Officers in Selection Grade with six years of regular service in that grade or (iii) Group A officers having twenty years of regular service in Group A of which at least six years continuous service shall be in the Selection Grade. <u>Essential:</u> A Master/Bachelor's Degree in Business Administration/Economics/Commerce/Engineering/Law/ Science/Humanities from a recognized University/ Institution or Membership of the Institute of Chartered Accountants of India/Institute of Cost and Works Accountants of India and possessing requisite experience in the Financial Analysis related field. <u>Age:</u> Not exceeding 56 years on the date of closing of applications

Note : Persons having aforementioned essential qualification/experience and holding the post having HAG Pay scale of Rs.67000- (annual increment @ 3%) - 79000/-) on regular basis or (ii) officers in SAG with six years of regular service in that grade or (iii) Group A officers having twenty six years of regular service in Group A of which at least six years of continuous service in the SAG may also apply and in case of selection he/she shall be considered for appointment as Principal Advisor (FA) in HAG Pay scale of Rs.67000- (annual increment @ 3%) - 79000/-).

2. TRAI has been exempted currently from the rule of immediate absorption upto 23.01.2011 by Department of Pension and Pensioner's Welfare for appointment on deputation. The Appointing Authority may, from time to time, by appropriate order, appoint on permanent absorption basis any person already appointed on deputation in the Authority in accordance with provisions contained in TRAI Appointment Regulations.

All the Ministries/Departments, Public Sector Undertakings and Statutory Autonomous Bodies are requested to forward applications in the enclosed proforma (can also be downloaded from TRAI website www.trai.gov.in alongwith attested copies of ACRs for the last five years and vigilance/disciplinary clearance of eligible candidates whose services could be placed at the disposal of the Authority immediately in an envelope superscribing the post applied for so as to reach the Senior Research Officer (A&P), Telecom Regulatory Authority of India, Mahanagar Doorsanchar Bhawan, J.L. Nehru Marg, (Old Minto Road), next to Zakir Husain College, New Delhi-110 002 on or before **31st December 2009**.

4. **Candidates who had earlier applied for the post of Principal Advisor (FA) in response to the circular of even number dated 24th April, 2009 need not apply again.**
